RAFFLE RULES

All Raffles

Raffle Rule Requirements

- Ticket purchasers must be 18 years of age or older, and the name of a minor must not be written on the ticket;
- b) Persons prohibited from purchasing tickets are: Casino/Raffle Chairperson, Raffle Ticket manager
- 4,000 tickets must be sold before requesting a draw date extension or a cancellation of the raffle.
- d) Purchase price of each ticket is \$20.00
- e) 7,000 tickets will be available for each Licence;
- f) Grand Prize Draw of a New 2024 Ford Bronco Sport Outer Banks 4 X 4 will be drawn on August 27th 2024, The 2024 Ford Bronco Sport Outer Banks 4 X 4 must be picked up in Stettler and any costs associated to pick up the prize are the responsibility of the winner.
- g) Second Prize draw for \$1,000.00 (cash) drawn on August 27th 2024; Third Prize draw for \$500.00 (cash) drawn on August 27th 2024
- h) First raffle ticket drawn will be for the Grand Prize of a New 2024 Ford Bronco Sport Outer Banks 4 X 4; Second raffle ticket drawn will be for a Cash Prize of \$1,000.00; Third raffle ticket drawn will be for a Cash Prize of \$500.00. The winning raffle ticket for all three draws will not be eligible for more draws in that raffle Licence.
- i) First Prize Awarded will be the Grand Prize of a New 2024 Ford Bronco Sport Outer Banks 4 X 4; Second Prize Awarded will be the cash prize of \$1,000.00; Third Prize Awarded will be the cash prize of \$500.00. All three prizes drawn will take place at Stettler Agricultural Exhibition Grounds at (4516 52nd street Stettler AB) the draw will take place open to the public
- Stettler District Agricultural Society will be responsible for awarding all prizes and ensuring that all reasonable efforts have been made to contact the prize winners.
- k) The winners of the prizes shall be determined and publicized. The winners will be notified by telephone. Winners shall be published on our social media sites.
- Any prizes which are not claimed shall be secured or placed in safekeeping for a period of six (6) months from the date of the draw. If at that time the prize has still not been claimed, the prize or monies equivalent to the fair market value of the prize shall be donated to a charitable beneficiary approved by the licensing authority.
- m) Only the prizes as described and approved in the license application shall be awarded. There will be no 'cash' alternative for the Grand Prize.

No Refunds

- a) No Refunds: All ticket sales are final. There will be no refunds issued to anyone for any reason
- All tickets purchased and for which the raffle numbers on those respective tickets are entered into the draw cannot be refunded, including if a ticket purchaser made an error in selecting the amount of tickets they desire to purchase.
- Only one name can be assigned per ticket; if more than one name is written on a winning ticket stub, the prize will be awarded to only one of the individuals named on the ticket stub; neither the licensed non-profit/ charitable organization nor AGLC is responsible for any disputes among individuals.

Payment by cheque

1. Cheque payment must be received seven (7) days prior to draw date to be entered into draw. Non-Sufficient Funds (NSF) cheques returned by the bank will be subject to a service charge of \$35.00.

Financial Controls

- a) Procedures for the:
- Ticket Inventory will be stored in locked cash room at Stettler District Agricultural Office (4516 52nd Street – Stettler AB)
- 2. Distribution of tickets to sellers, including signature confirming sellers have received tickets documented through raffle ticket Inventory control worksheet
- 3. Return of sold and unsold tickets documented through raffle ticket inventory control worksheet
- 4. Sage 50 Accounting system
- b) Frequency of revenue deposits;
- 1. Deposit will be made through cash, POS, Cheque or e transfer
- 2. Cash receipts can be made daily, any that are not deposited will be kept in the in floor safe in the cash room at Stettler Ag Society
- c) Marjorie Savage Stettler Ag Society Administrator will be responsible for:
- 1) Collection of sold and unsold tickets
- 2) Payment collection; and
- 3) Deposit of ticket revenue
- 4) Estimated expenses will be paid with non-gaming funds
- d) Record or control system for bearer ticket raffles that shows:
- 1) Tickets that are allocated to sellers will be documented through an inventory control sheet, with sellers names, name of the individual or organization i.e. Stettler 4-H Club, and the individual that has allocated the tickets
- Cash will be returned with the sold ticket receipts to Stettler Agricultural Society office, Marjorie Savage will confirm the amount sold reconciles with the sum of cash Stettler District Agricultural Society – Raffle Accounts over \$20,000.00
