This will be an indoor market for all things Homesteading! Consigners will be assigned a booth, please indicate on the vendor application form how much space you require.

ENTRY INFORMATION:

Live animal entries permitted to be sold are listed below.

Pricing of all entries will be done privately between consigner and purchaser. The SDAS or the Committee will not be responsible for any entries.

Non Animal Vendors - We are looking for local, handcrafted wares as well as commercial items that may be required on a homestead, such as incubators, animal feed, gardening tools, beekeeping supplies etc. Baking is not permitted.

Upon arrival at the sale, the Homestead Market Committee reserves the right to inspect any and all live animal entries by a Committee member and, upon the recommendation of that member, shall order the removal from the sale premises any animal having a physical defect, communicable disease, or being inferior in quality or condition.

CONSIGNER'S RESPONSIBILITIES:

Consigners are to arrive between 8:00 am and 10:00 am, be ready to sell by 11:00 am and finish at 4:00 pm.

THE HUMANE TREATMENT OF ALL LIVE ENTRIES IS PARAMOUNT. CONSIGNERS ARE TO MAKE SURE ALL LIVE ENTRIES HAVE APPROPRIATE SHELTER, FOOD AND WATER THROUGHOUT THE DAY.

All live entries (birds, animals, etc.) Must be contained in an appropriate cage/container/pen for the animal the entire time the animal is on the Stettler District Ag Society grounds.

SMALL ANIMAL: Consigners are to have suitably appropriate crates in size and reinforcement for purchasers to take purchased animals home.

LARGE ANIMAL: Consigners are to make sure all animals are contained and controlled throughout the whole day. Pens are available to be rented from the Stettler District Ag Society

All consigners to the sale are committed to abide by the Standard Breeder's Guarantee, individual consigners may provide further guarantees with their offering, by so stating when their offerings are in the sale:

- A) Certain species of Birds and Animals are controlled by:
 - 1) Federal regulations - The Migrating Birds Convention Act
 - 2) Alberta Provincial regulations - Wildlife Acts and Regulations
- B) Any persons wishing to sell, buy or show/exhibit, birds or animals controlled by the above acts may require an import or an export permit as the case may be.
- C) All consigners and buyers are required to make themselves aware of the requirements of the above acts and obtain the necessary permits as needed and abide by the regulations governing the acquisition and sale of any controlled bird or animal. It is the responsibility of each person to contact their local Wildlife Management Office to determine if they require any permits, etc.
- D) Permits and Game Bird License numbers must be clearly attached or legibly written on sale container.

All sheep and lambs that arrive must have the mandatory CSIP approved RFID tag as per Canadian Sheep Federation program. The animals that require RFID Tags must abide by all

CCIA rules & regulations.

It is **recommended** that consigners:

- Provide all purchasers with name and contact information for any potential inquires afterwards from purchasers. (Sample sheet attached for your use, if desired)
- Please attach a list of the lots you are planning to sell through this market so we can review and make sure that they will all be permitted to sell through this market.

Unloading & Parking:

Doors will open at 8:00 AM for set up, you will move in through either of the two doors at the east side of the Agriplex. Once you have finished unloading please move your vehicle and park on the west side and enter through the Pavilion. Patrons will be using the east parking lot and entrance please keep this open for them.

NOTES:

- NO CATS OR DOGS
- No limit on number of entries per consigner
- Booth Assignment in order of registration so register early
- We will have a food truck on site parked at the east entrance into the Agriplex
- This is an indoor market(weather permitting we may move some vendors outside) and will follow all public health orders. If we are forced to cancel because of any changes to the public health orders a full refund will be given.
- Consigners must have hand sanitizer available at their booth
- All current (as of May 08, 2021) AHS COVID-19 guidelines must be followed, e.g. maintaining 2 meter distancing, face masks & frequent hand washing/sanitizing.

FEES:

Booth's: 8X10 \$30, 10X10 \$40, 10X20 \$60

Additional Services: Pen's are available for an additional \$25 & must be purchased with a booth.

Refund Policy: The only instance in which a refund will be given is if SDAS is forced to cancel the event **OR** if there are not enough consignors registered to make the event viable

The SDAS & the Committee reserves the right to ask any consigner to leave the sale premises if the committee finds that a consigner has not treated animals humanely or represented the sale and the SDAS appropriately.

The SDAS acts as an leaser only and the SDAS will not accept financial responsibility between buyer and seller under any circumstance.

Notwithstanding to the contrary anything herein contained, it is understood that each entrant, by the act of entry or exhibiting, waives all claims against the Stettler District Ag Society, and/or any of the members, officers, or agents thereof, for any and all injury, loss or damage which he, his employees, helpers and/or property may sustain arising in any way out of the operation or activities of the said Associations officers, members or agents and indemnifies the said Association, officers, members or agents from and against any loss or damage sustained by the said Association by reason of any claim made by any of his helpers or assistants introduced to or engaged by any entrant through the said Association or any of them through their members, officers or agents shall be at the sole risk and responsibility of such entrant.
